The grant for your dwelling can reach 95% of the cost recognized for the realization of eligible projects, but not exceeding \$20,000 or \$25,000. The percentage of aid varies according to household income. Your home must require eligible projects of at least \$3,500 that aim to correct one or more major defects, which will be identified by the municipal partner during an inspection visit.
